

Application for Vendor Mart at StL3 Events

StL3, Inc. is a long standing, alternative lifestyle education group located in St Louis, Mo. We produce two events each year; 'Beat Me in St Louis' in the spring and 'Spanksgiving' the weekend before Thanksgiving. In our vendor mart, we try to keep the overall selection of vendors to respectful design as to give our attendees a great selection and not overload our vending area with too many of the same products. As we prepare for each event, we look at the needs for that event and select our vendors accordingly.

Our events average 400 registered attendees, plus another 50 'Saturday day passes' to the classes and vendor mart. We limit our vendor mart to a maximum of 15 vendor spots, per event. Vendor Mart hours will closely follow classroom hours. Vendor fee of \$260 includes the following;

2 full access registrations to the event (Pre-registration required)

Booth space averaging 120 sq ft (usually 10x12)

One table, two chairs

Early load in on Thursday night if desired

Free electric (Please bring your own extension to branch out to our hub.)

Free wi-fi

Free parking

Full access to the event and play areas,

including our famous, free, late night appetizer buffets on both Fri & Sat nights!

No hidden fees!! (Hotel accommodations are not included in this amount.)

We believe this is the best practice, not only for our events, to keep our vending area fresh, but for the vendors themselves so that everyone gets a chance to be a part of the great events we have built over the years here in St Louis.
